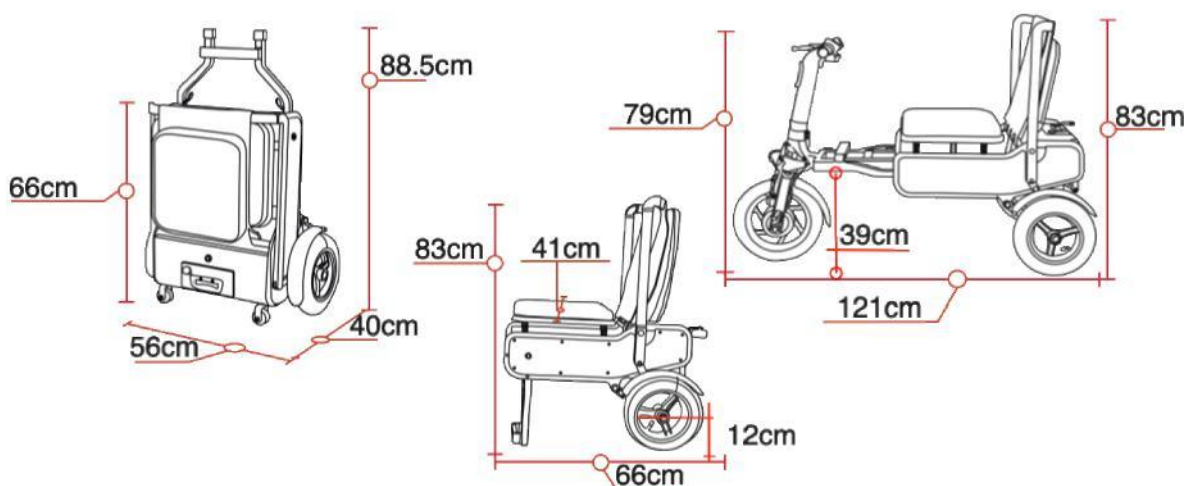

Remove spilled liquid with absorbent and incinerated. If leakage of the battery happens, liquid could be absorbed by using sand, earth or other inert substance and contaminated area should be ventilated meantime.
